

GENERAL DESCRIPTION

The British in India Book Prize

An annual prize of £1000 for an original work that makes a significant contribution to advancing knowledge or understanding of the history of the British in South Asia and is the author's first or second sole book publication.

DETAILS

The British in India Book Prize 2023

The British in India Book Prize 2023 rewards excellence in writing about the history of the British in South Asia by first- or second-time authors of books published in 2022. The winner will receive £1000. The winning entry will be decided by a panel of three judges.

Time frame

Submissions for the 2023 Prize open on 1 September 2022. Entries close on 31 December 2022. The winner is announced in May 2023.

Organisation

The British in India Historical Trust invites publishers, including university presses, commercial publishers and non-UK publishers, to submit a list of books they would like the Trust to call in for consideration. The Trust may also call in any other eligible book. A shortlist will be selected from which the winner will be chosen.

Entry of books

1. Publishers should submit one copy of called-in titles, or a PDF if a finished book is unavailable, by 31 December 2022.

3. Publishers should submit two additional copies of shortlisted books and complete a submission form.
4. Books should be submitted by publishers. The submission of a book by a publisher will be taken as agreement that the author is willing for the book to be considered and will abide by the rules of the prize. It is the publisher's responsibility to obtain the author's consent before entering the work.
5. Authors should encourage publishers to propose their book for consideration. No submissions will be accepted from authors unless requested by the Trust.
6. No books will be returned.
7. The selection of the shortlist and the judges' decision are final. No discussion or correspondence will be entered into.
8. The Trust reserves the right to make no award in a particular year.

Eligibility

1. Books must be the author's first or second solely authored work of history.
2. Books must be original works of research that make a significant contribution to advancing knowledge or understanding of the history of the British in South Asia.
3. Books must be first published in English between 1 January 2022 and 31 December 2022.
4. Books must be made available for sale or distribution in their country of publication between 1 January 2022 and 31 December 2022. Publishers must advise the Trust if a book's publication is postponed to the following year.
5. Authors of any age and nationality are eligible.
6. Books must not be written by more than one author.
7. Books may cover any aspect of the history of the British in South Asia, including historical biography.
8. Books may be published in hardback or paperback (provided the latter is the book's first publication).

9. The following are not eligible:

- books with any fictional content
- reprints, revised editions or paperback editions of previously published books
- books previously published under a different title or in a different format
- posthumously published books
- self-published books, including those produced by a company set up by the author and those whose publication is subsidised by the author in whole or in part or by anyone on behalf of the author
- essay collections by more than one author
- textbooks
- eBooks
- anonymous books

10. Publishers should ensure submissions comply with the entry and eligibility requirements. Any enquiries about eligibility should be addressed to info@britishinindia.org.uk.

11. The decision of the Trust as to whether a work is eligible shall be final.

Judging criteria

The winner of The British in India Book Award shall:

- make a significant contribution to advancing knowledge or understanding of the history of the British in South Asia; significance will be assessed on the basis of originality and excellence of content, presentation and literary style
- be accurate, thoroughly researched and include references and bibliography that demonstrate appropriate sourcework
- be written in a style that makes its subject accessible to the non-specialist reader
